PUBLIC COMMENT:

Representatives from Tire Aggregate, LLC were present to present a proposal to repair the ongoing problems on Degerman road by raising the road 4' by adding 2' of shredded tires with 2' of gravel on top of that. They said that they have been in business 5 years and have done most of their work in Minnesota. A detailed proposal for 1,900 feet of road would cost \$3,500-\$5,000. A ballpark estimate of a total cost of the project came to \$350,000. It is not a project the Town would be interested in at this time.

The department applied for a State EMS Flex grant requesting funding for medical equipment, apparatus, training and EMR retention. \$12 million is available state wide.

Mike submitted the paperwork for reimbursement for the DNR grant.

There were many responses to the department request for donations of sturffed animals. They are

given to children (or adults) that would be comforted by them at emergency calls.

Mike was asked about requiring fire inspections for Air BNBs. At this time inspections are not required. He will check with Lake Nebagamon to see what they do.
